# European Multi-Stakeholder Platform on ICT Standardisation

## 11<sup>th</sup> Meeting 26/02/15 - List of Decisions

At the meeting of 26 February 2015 the following operational decisions were taken:

1. Agenda item 2 (*document ICT/MSP (2014)296r2*): the **agenda was adopted** with a change regarding the presentation of EPO (agenda point 7) that was moved to the morning session.
2. Agenda item 3 (*document ICT/MSP (2014)293*): the **minutes from the previous MSP meeting** of 4<sup>th</sup> December 2014 were approved with one change for point 6.2. requested by NL in the sense of mentioning in the minutes that only 5 evaluation reports would be produced for the 28 IETF TS. The **decisions' list** (*document ICT/MSP (2013)294*) was approved without comments.
3. Agenda item 4 (*document ICT/MSP (2014)182v1*) the proposed change to the **guidance document on the evaluation process** was not approved. The previous version remains valid. FR expressed disagreement and asked this to be recorded in the minutes.
4. Agenda item 6.1 (*document ICT/MSP (2015)298*): **Identification of XBRL 2.1**: MSP gave **positive advice** to the identification by the Commission for referencing in accordance with Art 13 of Regulation 1025/2012.
5. Agenda item 6.1 (*document ICT/MSP (2015)303*): **Identification WCO Data Model version 3.3**: the decision was taken to send the report back to the evaluation working group and present it again at the next MSP meeting. The evaluation working group membership was extended to DE and UN/CEFACT.
6. Agenda item 6.1 (*documents ICT/MSP (2015)299, 300, 301*): **Identification of eSens: ebMS3-AS4, BDX location, ebCore-PartyID**: MSP gave **positive advice** to the identification by the Commission for referencing in accordance with Art 13 of Regulation 1025/2012.
7. Agenda item 6.1 (*document ICT/MSP (2015)302*): **Identification of OAI-PMH version 2.0**: MSP could not give positive advice due to some doubts raised about the lack of formal status of the organisation OAI-Open Archives Initiative.
8. Agenda item 6.2 (*document ICT/MSP (2015)305*): **Evaluation of AS2 IETF**: The MSP agreed to set up an evaluation-working group to evaluate AS2. The following members expressed interest in the evaluation: Commission (secretariat), DK, NO, IETF, IEEE, DIGITALEUROPE, CEN, CENELEC. The chair has not been decided yet.
9. Agenda item 6.2 (*document ICT/MSP (2015)304*): **Evaluation of CMIS version 1.0**: The MSP agreed to set up an evaluation-working group. The following members expressed

interest in the evaluation: Commission (secretariat), CH, OASIS (observer), DIGITALEUROPE, and possibly DE and UK. UK will confirm at a later stage if they take the chair.
