Best practices




- Drug stores: data on the location of drug stores, their office hours and their drugs selling prices is shared. Citizens and businesses can easily understand the data, as it is published using the standard format and is compliant with the European Statistics Code of Practice.
- Sofia Urban Mobility Centre: providing data on transport vehicles schedules in real time. Thereby, the system helps citizens optimize their use of the urban transportation system and save time.

Next steps

- Organizing a number of events, including high level ones by the Vice Prime Minister responsible for the administrative reform
- Training of public officials
- Carrying out information campaigns
- Prioritize which information should be open per administration and after that the actual data openness will be assessed




Bulgaria – Rankings


